6. DIRECT DEBIT REBATE

Direct debit rebates are not applicable for this product.

7. ADDITIONAL PRODUCT INFORMATION

Initial Three Month Trial Period

Customers have an initial three month period to trial Aurora's PAY AS YOU GO market offer. If a customer exits the product within this initial three month period, the meter removal fee of \$55.00 is not applicable. The initial three month trial period is also available for customers that move into premises that already have an Aurora PAY AS YOU GO prepaid meter.

Cost of Additional Smart Card

One Smart Card is provided with each PAY AS YOU GO prepaid meter installation. A cost of \$20 per additional Smart Card is applicable. This cost is not applicable if a faulty Smart Card is being replaced.
